

## Special Additional Terms for SCC/RMC Customers

Updated February 2013

This information is in addition to and forms part of the General Terms and Conditions of Trading with ABS Embroidery, a full copy of which is available on request and which can also be found at [www.absembroidery.co.uk](http://www.absembroidery.co.uk).

1. I operate a "no minimum order" policy on most lines. Items are priced according to quantities ordered. A full price list can be found in the catalogue at [www.absembroidery.co.uk](http://www.absembroidery.co.uk) and in any other version which may be available from time to time.
2. Discounts are offered on garment and additional garment embroidery purchases to SCC/RMC Units and other recognized SCC/RMC organisations only and are not available to individuals (whether SCC/RMC or not) or to the general public. I should point out however, that you do not need to be ordering "official" SCC or Unit goods, provided that you are representing a group within the organisation.
3. Discounts are offered in accordance with the scale shown below and are **not negotiable**. They are offered in addition to the price scales detailed in the catalogue and apply to the total quantity of items ordered, regardless of mix.
4. Prices and discounts **DO NOT** include shipping and handling, which is charged on the basis of weight.
5. In order to keep my prices as competitive as possible, no discount is currently available for badges.
6. ABS Embroidery is not currently VAT registered and therefore there is no VAT to add to the prices quoted. This may be subject to change in accordance with current legislation.
7. **Payment terms are Payment with Order. However, I will accept orders from SCC/RMC units by phone or e-mail strictly on the understanding that your cheque is posted first class, or your BACS, Credit/Debit Card or PayPal payment is made IMMEDIATELY on receipt of my confirmation and/or invoice, in which the total cost and order number will be quoted. A separate invoice will be raised for your records as required. Goods will be despatched after the cheque has cleared. If you wish to pay by BACS, please use the details shown on your invoice or contact me for details. To pay by Credit or Debit card please call 020 8262 1193. PayPal payments should be made to [accounts@absembroidery.co.uk](mailto:accounts@absembroidery.co.uk) .**
8. Please supply with your order:
  - a. A full delivery address (including postcode) and also a full invoicing address, if different
  - b. A contact name
  - c. A contact telephone number
  - d. A current e-mail address if available
  - e. An order reference. If none is available, ABS Embroidery will use the contact name
9. ABS Embroidery does not hold stock but obtains garments to order. It is **absolutely vital** therefore that **payments** are **received promptly** to allow settlement with my suppliers. **On no account will any goods be despatched until full, cleared payment has been received.** Please allow up to 28 days from receipt of payment for delivery.
10. **All items are subject to availability.** I reserve the right to substitute items of similar or better quality where ordered goods are unavailable. Should this incur a variation in price, I will inform you at the earliest possible time.

The Discount Scale for Garments is as follows:

<u>Order Quantity</u>	<u>Discount</u>
1 – 6	<b>NO DISCOUNT</b>
7 – 12	<b>5%</b>
13 – 24	<b>7½%</b>
25 +	<b>10%</b>

In order to keep prices as competitive as possible, it IS NOT possible for me to offer discounts on badges

11. Please state clearly which SCC/RMC Unit etc you are representing when making your initial enquiry.
12. There is **NO SETUP CHARGE to SCC/RMC customers** who are intending to purchase goods and/or embroidery services from ABS Embroidery. The price for digitising artwork with no subsequent embroidery purchase is £25.00 per design.
